## U.S. Citizens and Permanent Residents Identification Checklist



### **General Information**

- All documents must be unaltered certified originals, certified amended originals, or true copies certified by the issuing agency. Photocopies, notarized documents, and online printouts are not accepted. Miniature and wallet sized documents are not accepted.
- You must provide your Social Security Number. You can either present a document that shows your number (e.g. Social Security card, W2, 1099) or provide it verbally. Your Social Security Number will be verified through the Social Security Administration.
- If you are transferring driving privilege, you must also provide your driver license (valid or expired less than one year) or a motor vehicle report from your previous state/U.S. territory (dated within 30 days and showing a license that is valid or expired less than one year).
- U.S. citizens and permanent residents will receive a Real ID-compliant document. O

### Step 1 – Identity and Lawful Presence

Bring two of the following:

Bank Statement

Vehicle registration/title

Phone/Utility bill (with service address)

Pay Stub

First class mail (with dated postmark)

Credit card statement

Insurance Policy

Rent receipt (not handwritten)

Lease agreement/mortgage statement

Document must show applicant's name and current Colorado residential (not P.O. Box) address - including street address, city, and state.

Document must be dated within **1 year** showing full date. Electronic documents are accepted for proof of residential address.

### Step 3 – Check Your Name

If your Step 1 document does not show your full name (including middle name) or shows an initial, you must present an additional Step 1 document to prove your full name.

If your Step 1 documents show different names due to name change(s) you must provide at least one the following:

Certified Marriage Certificate	Certified U.S. divorce decree	Certified U.S. court order of name
	(showing change of name)	change or U.S. adoption order

If you have had more than one name change you will need to bring as many documents as needed to connect the names shown.

### Veteran/Military Indicators:

Bring your DD214 or Retired/Active Military ID to get a Veteran or Military Indicator added to your license or ID.

### **Organ, Eye & Tissue Donation:**

You will be asked about organ, eye and tissue donation during your application. Please consider your choice in advance.

### **Exceptions Processing:**

If, for reasons beyond your control, you cannot provide the required documents, you may be eligible for Exceptions Processing. Visit our website to learn more: *Colorado.gov/DMV/exceptions-processing* 

### **Translation / Interpreters**

If you need language assistance to complete your application, a Pocketalk translation device is available at all offices. You may also bring a friend or family member to assist.

# Document Checklist for Star Card – Idaho's REAL ID

ALL NEW APPLICANTS ARE REQUIRED TO PRESENT PROOF OF U.S. CITIZENSHIP IN THE FORM OF A U.S. BIRTH CERTIFICATE (IF OBTAINABLE) OR LAWFUL PRESENCE, AN ACCEPTABLE PHOTO IDENTITY DOCUMENT, TWO PROOFS OF IDAHO RESIDENCY, AND PROVIDE AN SSN THAT VERIFIES WITH THE SOCIAL SECURITY ADMINISTRATION.

An applicant is considered new if they have never been issued an Idaho credential, they are surrendering a credential from another jurisdiction to obtain an Idaho credential, or their Idaho credential has been expired for 25 months or more. If a certified original copy of a U.S. birth certificate is unobtainable, we may accept a passport or other government issued document that provides satisfactory evidence of a person's full legal name, date of birth, and lawful presence.

NOTE: If you currently have a valid Idaho credential, any of the documents listed in Step 1 may be acceptable for upgrading to a Star Card.

## Step 1 - Prove Your Identity (One Document)

### The following documents MUST be original, valid, and unexpired.

**Note:** If any of the referenced documents were used to support a previous license or ID issuance, and ITD retained imaged copies of these documents, you will not need to submit the document again when applying for a Star Card. (This only applies to documents that do not have an expiration date)

US Certified Birth Certificate from Vital Statistics <b>and</b> additional government-issued photo ID (birth records and hospital-issued certificates are not accepted)	Certificate of Citizenship (Form N-560, N- 561, or N-645) Permanent Resident Card (Form I-551)
Valid unexpired US Passport or Passport card in current legal name	Employment Authorization Document (EAD) (Form I-766 or I-688B)
Consular Report of Birth Abroad (Form FS-240, DS-1350, or FS-545) <b>and</b> government-issued photo ID	Foreign Passport and I-94, I-20, DS-2019, or EAD card
Certificate of Naturalization (Form N-550, N-570, or N-578)	

## Step 2 – Check Your Name

### Is your current full legal name on your driver's license or identification (ID) card?

Does your name match your identity document from step 1?

If YES, skip to Step 3

If NO, continue with Step 2 and provide the appropriate documents

Applicants who have who have changed or established a new name through marriage, adoption, court order, or other means are required to provide all documentation linking every name change made since birth.

• Accepted documents include recorded or certified marriage license(s), divorce decree(s), and court directed name change(s).

• Photocopies are not accepted. A certified marriage license proves that the marriage has been recorded by the issuing agency or office, and is dated after the ceremony date. In most cases, if your marriage license has original inked signatures and it was given to you directly after the ceremony by the officiant that married you, it is not a recorded and certified document. Contact the agency or office that issued the license for the required recorded or certified document.

US Certified Birth Certificate (see Step 1 for criteria)



Court order under petition for name change (stamped with court seal)

Court order for name change in divorce decree or

decree of annulment (stamped with court seal)

Certified and recorded marriage certificate(s) from Vital Statistics or county

Court order for name change in a decree of adoption (stamped with court seal)

## Steps 1 and 2: Lawful Identity, Age, and Name Change

**Idaho Vital Records** – For an original or certified copy of a birth, marriage, or divorce record, call (208) 334–5980, or visit <u>https://HealthAndWelfare.Idaho.gov/Health/VitalRecordsAndHealthStatistics/tabID/1504/Default.aspx</u>

**Marriage and Divorce** – For an original or certified copy of a marriage license or divorce decree, contact the county clerk or recorder's office in the county where the marriage license or divorce decree was issued. Cost will vary.

## Step 3 – Verify Your Social Security Number

Federal requirements stipulate that your social security number must be provided for verification. You may present a physical Social Security card, or if you know your social security number, you can provide it without the card.

The social security number you provide will need be verified by the Social Security Online Verification (SSOLV) Service. Your full legal name will need to be verified with the Social Security Administration (SSA). Check with the SSA first to change your name (if necessary) and allow 48 hours for all systems to update.

## Step 4 – Proof of Idaho Residency (Two Documents)



### U.S. Citizen, U.S. National and Permanent Resident Alien

### **IDENTITY**

#### Legal/lawful status verification MUST PROVIDE ONE (1) OF THE FOLLOWING:

- Valid, unexpired U.S. passport or passport card.
- Certified copy of a birth certificate filed with the State Office of Vital Statistics or equivalent agency in your state of birth (small laminated birth certificates or hospital certificates are not accepted.)
- Consular Report of Birth Abroad (CRBA) issued by the U.S. Department of State, form FS-240, DS1350, or FS-545.
- Valid, unexpired permanent resident alien card, conditional permanent resident card, form I-551.
- Certificate of Naturalization issued by DHS, form N550 or N-570.
- Certificate of Citizenship issued by DHS, form N-560 or N-561.

#### SOCIAL SECURITY CARD

#### MUST PROVIDE ONE (1) OF THE FOLLOWING:

- Social security card issued by the U.S. government that has been signed (stub will not be accepted.)
- If the social security card is not available, you may present one of the following documents that includes your name and full social security number:
  - W-2 form
  - SSA-1099 form
  - Non SSA-1099 form
- Pay stub
- Letter from the Social Security Administration indicating ineligibility to obtain a social security number as a result of legal/lawful presence status.

#### **RESIDENCY**

#### MUST PROVIDE TWO (2) OF THE FOLLOWING:

- Bank statement
- Court documents
- Current mortgage or rental contract
- Major credit card bill
- Property tax notice
- School transcript
- Utility bill
- Vehicle title

Residency is required for all originals, and if the address is different from what is on the current license record for renewals and replacements. Documentation must display your name and address, and the verification must be dated within 90 days.

**Note:** All documents presented must be certified originals or certified amended originals or true copies certified by the issuing agency.

- State Certified Birth Certificate
   (Not a hospital certificate of live birth)
- □ Valid U.S. Passport (Unexpired)
- Consular Report of Birth Abroad
- □ Certificate of Citizenship
- □ Certificate of Naturalization
- Valid Permanent Resident Card
- Valid Employment Authorization
   Document (may require additional documentation)
- □ Valid Foreign Passport and U.S. Visa



# Section 2: Proof of Current Residence (must present <u>*TWO*</u>)

**Note:** The documents must contain your name and current physical address (not a P.O. Box). For a minor child, a parent/guardian may provide the proof of residence in the parent/guardian name. **Documents can be no more than 30-45 days old. Amazon packages are not acceptable.** 

Any mail addressed to you at your current physical or residential address.

EXAMPLES: Utility bill, rent receipt, bank statement, insurance policy, telephone bill, mortgage document, vehicle registration, pay stub, tax document, voter registration, report card, magazine bill, doctors bill etc.



### Name Change—Must Present Proof (must present <u>ONE</u>)

- Marriage certificate
- Divorce decree
- □ Any name change order issued by a state or federal court or government

Wyoming Statute 31-7-111. Application for license or permit generally. (a) Every application for an instruction permit, driver's license, commercial driver's license or commercial learner's permit shall be made upon a form furnished by the division. Every application shall be accompanied by the proper fee, proof of residence and proof of identity. Proof of identity shall be established by a certified copy of the applicant's birth certificate, valid unexpired United States passport, consular report of birth abroad, certificate of citizenship, certificate of naturalization, permanent resident card, employment authorization document, foreign passport (with United States visa affixed and accompanied by an approved document documenting the applicant's most recent admittance to the United States), state issued driver's license or identification card which complies with federal law and applicable regulations, or other document required by the division to establish identity where reasons beyond the applicant's control prevent the applicant from presenting the documents required by this subsection.
